# **Notice of Public Meeting**

For a Proposed Minor Variance to Zoning By-law 32-2008 Planning Act, R.S.O. 1990, cP. 13., S. 45 (5)

A change is proposed in your neighbourhood. A Minor Variance Application has been received, that if approved, would grant one variance from the ACW zoning by-law to allow the construction of a new shed in the front yard of the subject property.

## **The Proposed Change**

The applicant is seeking to construct a new  $12' \times 16'$  shed in the front yard, to the east of the dwelling. Section 3.4.3 a) in the General Provisions of the ACW Zoning By-law requires that the structure must be erected in the rear or interior side yard. The location for the shed is proposed to be in the front yard, therefore relief is sought to allow for the construction to take place as proposed. All other setbacks will be maintained.

The subject property is designated Village in the ACW Official Plan. It is zoned VR1 (Village/Hamlet Residential – Low Density) in the ACW Zoning By-law.

## **Your Rights**

The applicant, the Minister of Municipal Affairs & Housing, or a specified person under the Planning Act may, within 20 days of the making of the decision, appeal to the OLT against the decision of the committee. This may be done by filing with the Clerk a Notice of Appeal setting out the objection to the decision and the reasons in support of the objection. This must be accompanied by payment to the Clerk of the fee charged by the OLT under the Ontario Land Tribunal Act, 2021 as payable on an appeal from a Committee of Adjustment to the OLT, in accordance with Section 45(12) of the Planning Act.
