# **Notice of Public Meeting**

For a Proposed Minor Variance to Zoning By-law 32-2008 Planning Act, R.S.O. 1990, cP. 13., S. 45 (5)

A change is proposed in your neighbourhood. A Minor Variance Application has been received that, if approved, would seek relief from Section 3.4.4 (Lot Coverage of Accessory Buildings) of the ACW Zoning By-law in order to construct a detached garage.

You are invited to participate in a public Meeting on Tuesday, September 12, 2023 at 7:00 p.m. During this time, the Township of Ashfield-Colborne-Wawanosh Committee of Adjustment will be considering the change.

## The Proposed Change

The applicants are seeking to construct a detached, double car garage. Section 3.4.4 of the ACW Zoning By-law stipulates that, within the LR2 zone, the total lot coverage of all accessory structures shall not exceed the lesser of 6% of the total lot area or the total lot coverage of the main building. The proposed garage, along with an existing shed, will exceed the lot coverage of the existing residence.

The subject property is designated Lakeshore Residential in the ACW Official Plan. It is zoned LR2 (Lakeshore Residential – Year Round) and NE1 (Natural Environment) in the ACW Zoning By-law.

### Your Rights

The applicant, the Minister of Municipal Affairs & Housing, or a specified person or public body who has an interest in this matter may, within 20 days of the making of the decision, appeal to the OLT against the decision of the committee. This may be done by filing with the Clerk a Notice of Appeal setting out the objection to the decision and the reasons in support of the objection. This must be accompanied by payment to the Clerk of the fee charged by the OLT under the Ontario Land Tribunal Act, 2021 as payable on an appeal from a Committee of Adjustment to the OLT, in accordance with Section 45(12) of the Planning Act.
