Regular Council Meeting– January 3, 2023

2022 Annual Accessibility Plan Updates and 2023 Multi-Year Plan

Council adopted the 2022 Annual Accessibility Plan Updates that the Huron County Accessibility Advisory Committee prepared and was subsequently presented with the 2023 Multi-Year Plan.

Coldest Night of the Winter- 2023 Sponsorship

Council agreed to a \$1000.00 sponsorship of United Way Perth-Huron's *Coldest Night of the Year* event on Saturday, February 25, 2023.

OLT-22-004185 OPA No. 12 – Update

Planner Celina Whaling-Rae gave Council an update on the Notice of Decision regarding OLT22-004185 OPA No. 12. Section 24 of the *Planning Act* prevents individuals from appealing an Official Plan in its entirety, Council was made aware that the revised Official Plan exclusive of Section 8.10 and subsequent mapping are now in full force and effect.

Huron County Community Safety and Well-Being Plan Oversight Committee

Councillor Anita Snobelen was appointed to the Huron County Community Safety and Well-Being Plan Oversight Committee. The Oversight Committee was established for the implementation and oversight of the Community Safety and Well-Being Plan that was adopted by Council in 2021.

Municipal Modernizations Update- Vidim-iCity Financial ERP System

In February 2022, the Township received notice that its application under the Municipal Modernization Program Intake 3 (MMP) was successful. The approved MMP project includes the implementation of Human Resource Information System (HRIS) and an updated financial management software system, with the goals of integrating human resource processes and eliminating the duplication of data entry. After evaluating alternatives, staff determined that Vadim iCity is the most suitable financial management system for ACW's current and future needs.
