Monthly Council Meeting Highlights July 2022

Regular Council Meeting– July 19, 2022

Appeal of Official Plan Amendment no. 12

In a report prepared by Planner, Celina Whaling-Rae, Council was advised that the County of Huron had received an appeal to the Ontario Land Tribunal (OLT) regarding ACW Official Plan Amendment no. 12 (5 Year Review). As such, the changes to the Official Plan resulting from the recent 5-year review are not yet in full force and effect. Council agreed to postpone the special meeting scheduled for August 12th to review the zoning by-law until a later date.

Century Heights Water Expansion EA – Construction of New Supply Well

Council accepted a proposal from W.D. Hopper & Sons Ltd. in the amount of \$81,815.00 plus HST for the drilling of a new supply well as part of the Century Heights Water System.
