# Monthly Council Meeting Highlights July 2023

## Council Meeting | Planning – July 11, 2023

Consent File C32-2023 Robinson

Council recommended to the County of Huron that the Consent Application C32-2023 Robinson be approved subject to the conditions as outlined in the Planner's Report.

#### OLT-22-004185 OPA No.12- Notice of Withdrawal

Council received a report prepared by Planner Celina Whaling-Rae as well as the Notice of Withdrawal regarding OLT-22-004185 OPA No. 12. Due to the withdrawal of appeal, the week-long hearing scheduled by the Ontario Land Tribunal for the matter in September will not proceed. This now brings the entirety of the Official Plan into full force and effect.

# Public Meeting- Committee of Adjustments

This Public Meeting was held as a requirement under the Planning Act to consider Minor Variances to Zoning By-Law 32-2008 for planning applications MV07-23 Hertel and MV08-23 Carter. As a result of agency comments received in support of the application, Council approved the applications subject to the conditions noted in the Planner's report.

#### Zoning By-law Update

Council received the report prepared by Planner Celina Whaling-Rae as an update to the amendments proposed to the Zoning By-law. Council supports staff to circulate the public notices for Open Houses and providing individual notice to landowners with proposed zoning changes. #### Council Meeting - July 18, 2023

#### Ashfield Park Washroom Tender

Council accepted the tender for the construction of a new washroom facility at Ashfield Park from Arcadia Custom Living. This project is partially funded through an Ontario Trillium Foundation Capital Grant.

## Lucknow and District Fire Board - Purchase of Pumper Truck

Council supported the purchase of the new pumper truck for the Lucknow & District Fire Department and that the funds required be transferred from the Lucknow Fire Truck Reserve and the COVID-19 Reserve. Additionally, a portion of the cost of the new pumper truck will be recoverable through Development Charges.

## Naming Private Roads By-law

Council adopted By-Law 49-2023, being a by-law to name Somerset Drive and Willow Court within the development of Saltford Heights.

## Seebach & Company Chartered Accountants

Council accepted the Financial Statements as prepared by Seebach & Company Chartered Accountants for the year ending December 31, 2022.

## Wellington Street Construction Tender and By-law

Council awarded the tender for the Wellington Street Construction to Roubos Farm Services Ltd. Council also introduced By-Law 53-2023 being a by-law to authorize the construction of, and provide for the estimated levying of the capital costs of the Wellington Street Improvement Project.

#### Westmount Line Culvert Tender

Council awarded the tender for the Westmount Line Culvert Replacement to Hanna & Hamilton Construction Co. Ltd.

#### Wylds Municipal Drain Branch A Improvement Engineers Report

Council accepted the engineer report for the Wylds Municipal Drain Branch A Improvement 2022 and gave first and second reading to the Provisional By-law.
