Monthly Council Meeting Highlights June 2022

Regular Council Meeting– June 7, 2022

Parks & Recreation Strategic Plan Request for Proposal (RFP) Results

Council accepted the proposal from thinc design (Tocher Heyblom Design inc.) for the development of a Parks and Recreation Strategic Plan for the Township of Ashfield-Colborne-Wawanosh. Staff have begun work with thinc design in June 2022 on this project.

Pride Month Flag Request

Council received correspondence from Huron Perth Public Health requesting that the Township recognize June as Pride Month and raise a Pride flag for the month. Council agreed to raise a Pride Flag for the month of June, flying the same flag as the County of Huron.

Port Albert Servicing Master Plan

Council was provided with a presentation prepared by Kelly Vader and Dale Erb from BM Ross & Associates Ltd. The purpose of the presentation was to allow council to review feedback received following publication of the Notice of Master Plan Completion, and to adopt the Port Albert Servicing Master Plan as is, or with modifications. Council proceeded to adopt the Port Albert Servicing Master Plan as drafted by BM Ross & Associates dated April 27, 2022 by by-law. By-law 49-2022 being a by-law to adopt the Port Albert Servicing Master Plan was passed.

Notice of Appeal - Zoning By-Law Amendment Application – File Z07-21 Lobo Sand & Gravel

The Township received a Notice of Appeal from 1142059 Ontario Limited (Lobo Sand & Gravel) on Zoning By-Law Amendment Application Z07-21 to the Ontario Land Tribunal (OLT), on the grounds of Council failing to make a decision within 90 days. With the submission of this Notice, the decision is no longer within the jurisdiction of Council.

Water Connection By-Law Amendment

At the June 7th meeting of Council, By-Law 50-2022, being a by-law to authorize the year-round operation of the Huron Sands Drinking Water System was adopted.

The system will now operate year-round, Huron Sands will no longer be considered a seasonal system. As such, By-Law 30-2016, being a by-law to regulate connection to the Municipal Water Systems in the Township will need to be amended.
