Regular Council Meeting- March 7, 2023

2022 Annual Drinking Water System and Compliance Summary Reports

Council accepted the 2022 Annual Water Reports as submitted by Veolia Water for the Benmiller, Century Heights, Dungannon, Huron Sands, Lakeshore, and Lucknow Drinking Water Systems. These reports are available on the website at: https://acwtownship.ca/municipal-services/public-works.

Parks & Recreation Strategic Plan - Update

Staff provided an update on the Parks & Recreation Strategic Plan process. Consultants are finalizing the implementation plan which will be shared with Township staff for review and circulation before it is included in the final plan. Council Meeting- March 20, 2023

2023 Proposed Budget

Council approved the 2023 Township Budget as presented. The Township levy for 2023 will be \$5,985,579 for Township purposes only. This reflects a 7.17% increase to the 2022 tax rate, which converts to an 10% increase to the 2022 Township levy.
