Monthly Council Meeting Highlights September 2023

Council Meeting – September 5, 2023

Ashfield-Colborne Lakefront Association - Extend Weekly Garbage Pickup

Council requested a report at budget time on the request from the Ashfield-Colborne Lakefront Association for extended weekly garbage pickup to include the months of May and October, Council also requested Staff consider the frequency of waste removal for all residents.

Huron Sands Water Connection By-Law Exemption

Council rescinded By-Law 53-2022, being a by-law to amend By-Law 30-2016, being a by-law to regulate connection to the municipal Water Systems in the Township of Ashfield-Colborne-Wawanosh. This will re-instate the residents of Huron Sands Water Systems' ability to operate their curb stop.

By-Law Enforcement Update and Summary 2023
