Notice of Proposed Official Plan Amendment

Planning Act, R.S.O. 1990, cP. 13., S. 17 & S. 21

The Township of Ashfield-Colborne-Wawanosh (ACW) is proposing changes to the ACW Official Plan.

An online Public Meeting for this proposed amendment took place on Tuesday, March 15th, 2022 at 7:00 p.m. The Council of the Township of Ashfield-Colborne-Wawanosh chose to adopt the proposed amendment on May 17, 2022. As such, it has been forwarded to the Council of the County of Huron for final approval. You are invited to submit your comments regarding these changes by Wednesday, June 1st, 2022.

The Proposed Change

A number of policy and mapping changes are proposed in the Official Plan amendment as a result of the Official Plan Review. Key proposed changes include:

- Implementing Maitland Valley Conservation Authority's (MVCA) Flood Hazard data set into the mapping;
- Introducing policies which allow for additional residential units on properties within the Agriculture and Village/Hamlet designations;
- Amending permitted uses in the Agriculture designation to allow for greater on-farm diversification;
- Revising economic development policies to provide a stronger community focus;
- Implementing a climate change lens throughout the Official Plan;
- Implementing source water protection policies;
- · Updating and correcting land use designation mapping;
- Clarifying development standards within settlement areas;
- Defining full-service access along the lakeshore;
- Providing compatibility criteria within the Airport designation;
- Outlining considerations for site plan control; and
- Stipulating requirements of a complete planning application.

If approved, these changes will apply across the Township of Ashfield-Colborne-Wawanosh.

This will also entitle you to be advised of a possible Ontario Land Tribunal (OLT) hearing if the decision of this application is appealed.

Your Rights

If the Council of the Township of Ashfield-Colborne-Wawanosh adopts the Amendment, the Record of the Clerk will be sent to Huron County Council for approval. The final decision is with Huron County Council. If a person or public body would otherwise have an ability to appeal the decision of the Council of the County of Huron to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Ashfield-Colborne-Wawanosh before the proposed Official Plan amendment is adopted, the person or public body is not entitled to appeal the decision of the County of Huron to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Ashfield-Colborne-Wawanosh before the proposed Official Plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

If you are receiving this notice because you are the owner of property in the area of the amendment that contains seven or more residential units, you must also post this notice in a location that is visible to all of the residents of your property.
