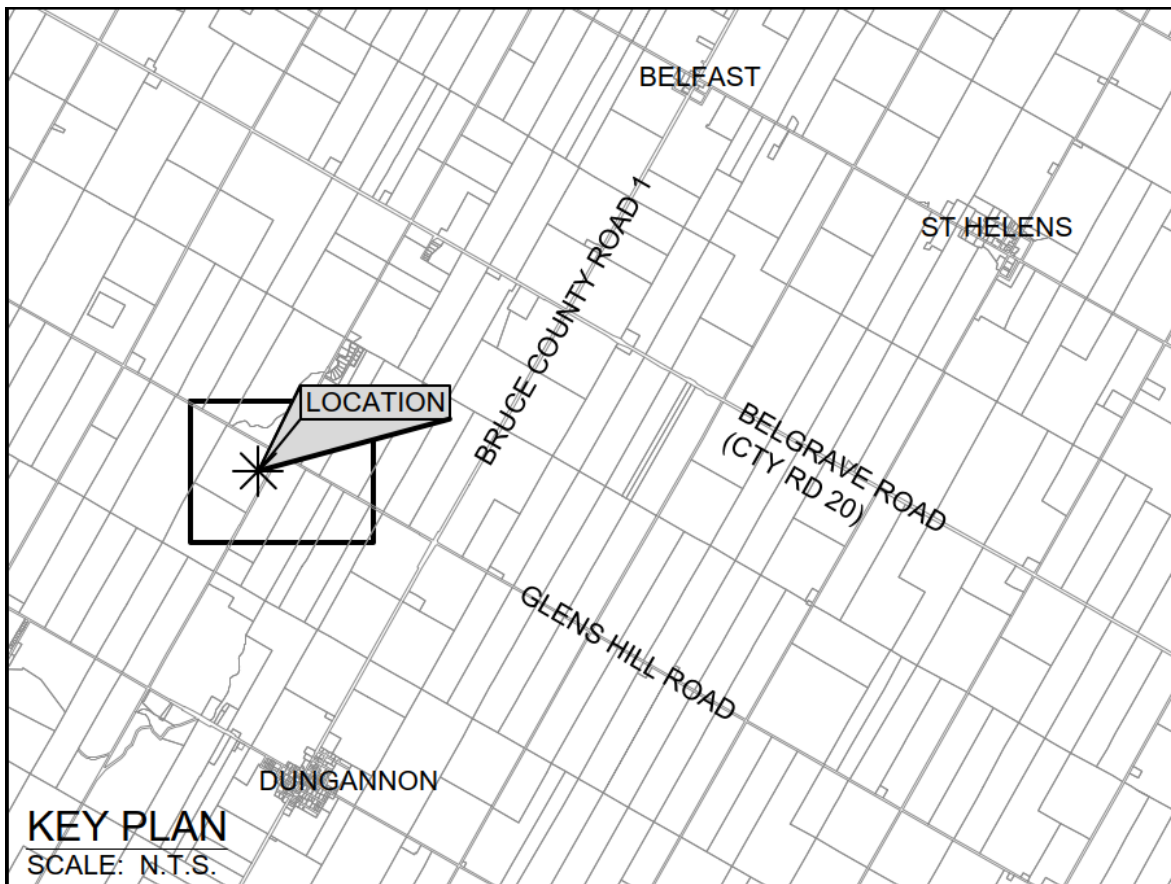

The **Township of Ashfield-Colborne-Wawanosh** has applied to the Ministry of Natural Resources to licence a portion of **Part Lot 9, Concession 6 Eastern Division, in the Geographic Township of Ashfield, in the Township of Ashfield-Colborne-Wawanosh, in the County of Huron. 16.62 ha (41 acres)** is proposed to be licensed to operate a **Class A Pit, above the water table** with a maximum annual tonnage of 100,000 tonnes.
