We understand the work is under the direction and supervision of the Township of Ashfield-Colborne-Wawanosh Public Works Superintendent and Lead Hands or other designated official of the Township of Ashfield-Colborne-Wawanosh.

Gravel to pass through <u>34"</u> (three quarter inch) screens, <u>minimum 60% crushed</u> material to produce 5/8" (five eights inch) material.

All material is subject to testing

- 14,000 Tonnes of Gran. A for Twp. Roads from Johnston Bros Mole Pit located on Glens Hill Road.
- 34,000 Tonnes of Gran A for Twp. Roads from Johnston Bros (Cunningham) Pit located on Blyth Road.

1. DEFINITIONS:

In these specifications, the following shall apply:

"Contractor" -Means the person, partnership or corporation whose tender has been accepted by

the Township for the work.

"Crushed Gravel" -Means the material produced in accordance with these specifications from natural

gravel deposits or quarries.

"Inspector" -The person or persons employed by the Township to assist the Public Works

Superintendent or Lead Hand work.

"Township" -Means the Corporation of the Township of Ashfield-Colborne-Wawanosh.

"Work" -Means to process by such labour, equipment and tools as may be required, and

apply or stockpile the crushed gravel under the directions and supervision of the

Public Works Superintendent or Lead Hand.

2. CLOSING OF TENDERS:

Sealed Tenders shall be received by Thursday, February 3, 2022 at 1:00 p.m.

OPENING OF TENDERS

Thursday, February 3, 2022 at 1:05 p.m. at the Ashfield-Colborne-Wawanosh Municipal Office located at 82133 Council Line. The public and any interested person may attend. Tender results of the opening will be available within 48 hours of the tender close.

Please be aware that all persons meeting in Township buildings (i.e. the Council Chambers) need to be fully vaccinated. For the tender opening, masks and proof of vaccination will be required for those wishing to attend.

The totals of each Tender shall be reviewed and Council will consider the tender at the regular meeting of February 15, 2022. Council meetings are currently held via Zoom, the link to participate in the meeting will be available on our website at https://acwtownship.ca/government/agendas-minutes.

4. ACCEPTANCE OF TENDER

The Township reserves the right to reject any or all Tenders.

The acceptance of a Tender by the Township shall be by Resolution of Council and upon passage of the Resolution of Council a contract exists.

RETURN OF DEPOSIT

The Certified Cheques submitted with the Tenders shall be returned to the unsuccessful tenderers within 7 days of the opening of Tenders. The successful contractor's Certified Cheque shall be retained by the Township until he has satisfactorily completed the contract.

6. LIABILITY INSURANCE

The Contractor shall take out and keep in force until the date of acceptance of the entire work by the Township, a comprehensive policy of public liability and property damage insurance acceptable to the Township providing insurance coverage in respect of any one accident to the limit of at least \$5,000,000.00 exclusive of interest and cost, against loss or damage resulting from bodily injury to, or death of, one or more persons and loss of damage to property and such policy shall name the Township of Ashfield-Colborne-Wawanosh as an additional insured thereunder and shall protect the Township against all claims for all damage or injury including death to any person or persons and for damage to any property of the Township or any other public or private property resulting from or arising out of any of his servants or agents during execution of the Contract and the Contractor shall forward a certified copy of the policy or certificates thereof to the Township before work is commenced.

7. NON-FULFILLMENT OF CONTRACT:

If the Contractor neglects or fails to commence the work, or fails to complete or proceed with the work, the Township shall have the right to retain the deposit cheque and use the money to complete the contract.

8. PAYMENT

After the work has been accepted by the Public Works Superintendent or other designated official, the contractor will prepare a detailed statement summarizing the final quantities and prices. The Public Works Superintendent will certify it to be correct and forward same to the Township for payment.

9. METHOD OF FEEDING THE CRUSHER:

The crusher is to be fed by front end loader. At the conclusion of the contract the pit is to be left in a tidy condition acceptable to the Township Public Works Superintendent or other designated official.

10. APPLYING CRUSHED GRAVEL:

The crushed gravel shall be spread uniformly on the roads as directed by the Public Works Superintendent or other designated official.

11. STOCKPILING CRUSHED GRAVEL, IF REQUIRED:

Stockpiles shall be built at the locations as detailed in the Tender. Stockpiles shall be constructed in layers not exceeding three (3) feet in thickness to prevent undue segregation of the aggregate. Stockpile to be paid by measurement using formula by the method of average and areas.

12. OTHER CONDITIONS:

- a) Contractor to bench bank to stay within legal height limits, and leave gravel pit benched after completing crushing.
- b) Contractor to comply with all Pits & Quarries Regulations, and also report to Workers' Compensation Board as required under the Act.
- c) Contractor to give Notice of Mining Activities to Ministry of Labour before installation of crushing equipment.
- d) Contractor will provide in writing that all employees entering the gravel pits have the required Surface Mining Certification Modules.

13. MISCELLANEOUS INFORMATION

- a) Contractor to supply and install scales or provide loader scales. Loader scales must print out weight for each load.
- b) Township may supply employee to check weights. Trucks may be sent to nearest weigh facility to verify accuracy.
- c) Gravel will be tested to meet Minimum 60% crushed material to produce 5/8" material.
- d) Township Lead Hands will measure screen sizes before crushing commences.

14. METHOD OF MEASUREMENT OF CRUSHED GRAVEL:

The Public Works Superintendent or other designated official shall determine and record the capacity of each truck calculated from measurements based on legal allowances. Such allowances to be determined by the Contractor and the Public Works Superintendent. Conversion Factor: 1 cuyd.=1.36Tonnes

15. BASIS OF PAYMENT:

Payment for crushed gravel either for stockpiling or applying on the designated roads shall be at the unit bid price.

16. H.S.T. REGISTRATION:

H.S.T. Registration Number must be on the Tender.

Standard Clauses

17. Protection of existing works

The contractor shall ensure that no damage is caused to any existing works. The contractor shall be responsible for all damage claims which are alleged to be due to the work performed under this contract or order.

18. Contractors risk

The contractor shall assume full responsibility as the public safety, public liability and property damage, and his workmen shall be covered by workers' compensation. In addition, work will conform to the requirements of the Occupational Health and Safety Act, and Regulations under this Act.

19. Acceptance and guarantee

No part of the work will be accepted until the Township is satisfied that it fully complies with the true meaning and intent of the specifications. Such acceptance, however, shall not impair any claim that the Township may have for the correction of defective work.

20. Tender deposit

Each tender must be accompanied by a tender deposit in the form of a **certified cheque** made payable to the Township of Ashfield-Colborne-Wawanosh in the amount of **10% of the tendered amount.** The tender deposit of the successful bidder will be held until the completion of the work and will be utilized as a performance bond.
